NAME: The name of this Corporation is RSD RENTALS & TOURS, INC., and its address is 430 N. Alexander St., Mt. Dora, FL 32757.





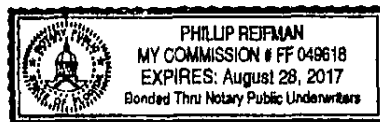
