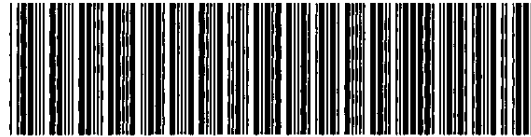

The undersigned, acting as incorporator of a corporation under Florida Statutes hereby adopts the following Articles of Incorporation for said corporation.

ARTICLE I - NAME: The name of the corporation shall be **AMERICAN PROPERTY RESTORATIONS, INC.**

ARTICLE II - PRINCIPAL OFFICE: The principal place of business and mailing address is: American Property Restorations; 3520 Marjean Drive; Pensacola, Florida 32504.
