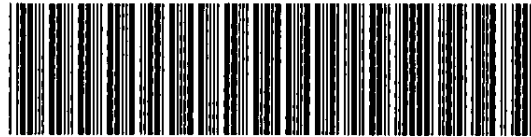

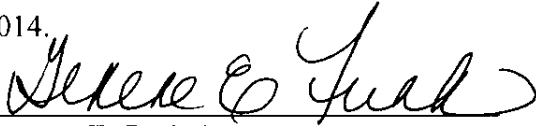

the Florida Business Corporation Act.

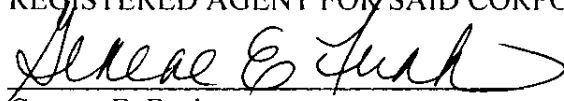
