# **ARTICLES OF INCORPORATION**

# OF

# **CELDAS CORPORATION**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

# **ARTICLE I**

The name of the corporation is: **CELDAS CORPORATION** 

#### **ARTICLE II**

The initial principal place of business and mailing address of the corporation in the State of Florida is: 6012 Glendale Drive, Boca Raton, Florida 33433. The board of directors may, from time to time, move the principal office to any other address.

#### **ARTICLE III**

The corporation will engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### **ARTICLE IV**

The corporation is authorized to have outstanding one class of stock designated as common stock. The maximum number of shares of common stock, which the corporation is

authorized to have outstanding, is 5,000 shares at par value of \$1.00 per share. Holders of the common stock are entitled to vote on all questions required by law as the basis of one vote per share and there shall be no cumulative voting.
