

#### **ARTICLES OF INCORPORATION**

OF

# **KEYPER, INC**



The UNDERSIGNED, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

#### ARTICLE I

# Name and Address

The name of this Corporation shall be KEYPER, INC., and its physical address shall be: 301 N Park Ave, Suite B, Winter Park, FL 32789, and its mailing address shall be: P.O Box 1211, Winter Park, FL 32790.

#### **ARTICLE II**

# Commencement of Corporate Existence.

This Corporation shall commence corporate existence on February 8, 2014, and shall have perpetual existence unless dissolved according to laws.

## **ARTICLE III**

#### Purpose

The purpose of this corporation shall be to engage in any and all lawful activities permitted under the Florida General Corporation Act, as the same now exists and as hereafter amended.

#### **ARTICLE IV**

# **General Powers**

- A. To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or facsimile thereof, to be impressed, affixed or in any other manner reproduced.
- B. The purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest herein, wherever, situated.
- C. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or part of its property and assets.
- D. To lend money to, and use its credit to assist its officers and employees in accordance with law
- E. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with,

- shares or other interest in, or obligations of, other domestic or foreign corporations,
- associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other governments, state, territory, governmental district, or municipality or of any instrumentality thereof.
- F. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any part of its property, franchises and income.
- G. To lend for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payments of funds so loaned or invested.
- H. To conduct its business, carry on its operations, and have offices and exercise the powers granted by law within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
- J. To make and amend bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for the administration and regulation of the affairs of the corporation.
- K. To make donations for the public welfare or for charitable, scientific or educational purposes.
- L. To transact any lawful business that board of directors shall find will be in aid of governmental policy.

Voting Rights. The Common Stock shall possess and exercise exclusive voting rights and at all
meetings of the shareholders, each record holder of such stock shall be entitled to one of vote

- for each share held. Shareholders holding Common Stocks shall have no cumulative voting rights in any election of directors of the Corporation.
- 3. <u>Preemptive Rights.</u> No shareholders of the Corporation shall have the right, upon the sale for cash or otherwise, of any new stock of the Corporation or any stock of the Corporation held by it in its treasury or otherwise, of the same or any other kind, class or services as that which he already holds, to purchase his pro rata or any other share of such stock and the same price at which it is offered to others or any other price.


