ARTICLES OF INCORPORATION
OF
SOBRIETY NOW, INC.**

FIRST: The Articles of Incorporation of SOBRIETY NOW, INC. were filed with the Florida Department of State on February 18, 2014, document number P14000015264.

SECOND: The Articles of Amendment to the Articles of Incorporation of SOBRIETY NOW, INC. were filed with the Florida Department of State on February 14, 2014, which such Articles of Amendment have been filed in error; and

THIRD: The Articles of Incorporation of SOBRIETY NOW, INC. are hereby amended and restated in their entirety to read as follows:

**ARTICLE I
NAME**
