ARTICLES OF INCORPORATION
OF
EVERGREEN INTERNATIONAL INC.

Pursuant to Chapter 607 of the Florida Statute (the "Florida Business Corporation Act"), the undersigned, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the corporation shall be EVERGREEN INTERNATIONAL INC. (hereinafter the "Corporation"), and the principal office shall be at 7830 Gunn Highway, Tampa, FL 33626

ARTICLE II DURATION

The period of duration of the Corporation shall be perpetual.
