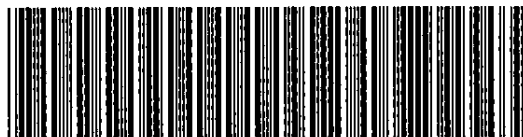

Name. The name of this Corporation is: Cherileo, Inc.
