**ARTICLES OF INCORPORATION
OF
LAKEVIEW ASSOCIATED ENTERPRISES-PHASE II, INC.**

In compliance with the requirements of chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is Lakeview Associated Enterprises-Phase II, Inc. ("Corporation").

ARTICLE II

The existence of the Corporation shall begin on the date of filing these Articles of Incorporation in the office of the Secretary of State of the State of Florida, and shall be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is 1221 W. Lakeview Avenue, Attn.: Executive Office, Pensacola, Florida 32501.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

ARTICLE VII

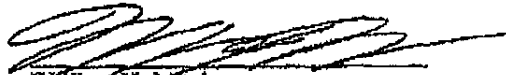
