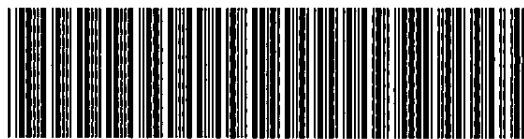

ARTICLES OF INCORPORATION
OF

FIRST: We, Robert Lane, Jr., 1005 Eastbourne Drive, La Plata, Maryland 20646, Barbara P. Torres, 2446 Streamview Drive, Waldorf, Maryland 20603, and Tijuana Dixon, P.O. 215, Clinton, MD 20735, being at least twenty-one (21) years of age, do hereby form a corporation under the laws of the State of Maryland.

SECOND: The name of the corporation is SRL TOTALSOURCE, INC.

THIRD: The purposes for which the Corporation is formed are as follows:

- a. To own, operate, conduct, and transact business for profit in the area of information technology, computer repair and general maintenance, infrastructure, video graphics; telecommunications; internet security, cyber security technology and maintenance; IT instruction on various subjects and development of training programs for individuals interested desiring to become IT technicians, Dental technicians, Medical Coders and all other subject matter within the scope of our expertise.
- b. To provide, instruction, products and manage Services for the Federal government to include but not be limited to the department of defense; state and local governments and entities; for profit and non-profit organizations; commercial corporations; and NATO approved countries.
- c. To provide and staffing; dental equipment and supplies for dental offices to include the Federal government.
- d. To provide staffing in the area of janitorial services for cleaning, painting, for commercial buildings to include but not be limited to, government buildings, corporate buildings, educational institutions, museums, statutes, etc..

- e. To provide medical billing and coding for sole practitioners, hospitals, training organizations, federal government to include but not be limited to the department of defense; state and local governments and entities; for profit and non-profit organizations; commercial corporations; and NATO approved countries.
- f. To provide training programs for returning residents from military and incarceration through governmental programs such as DOD, Veterans Administration, CSOSA, and any other entity the governments shall create.
- g. To provide insight and assistance to federal and local governments to prevent and reduce criminal recidivism and emotional health issues through job training and hiring.
- h. To create, market, distribute, produce, purchase, and sell merchandise to include, but not be limited to dental instruction manuals, pamphlets, kits, and instructional material for children and physically and intellectually challenged adults. Such information shall be in English, Spanish, or whatever language required by the purchaser.
- i. To buy, sell, lease, invest, own, operate all necessary products, stock, goods, wares, supplies and equipment of any kind, nature or description whatsoever necessary to perform any and all services incidental thereto, and to do all things necessary to the successful conduct of said business.
- j. To acquire by purchase or otherwise, own, hold, buy, sell, convey, lease, mortgage or encumber real estate or other property, personal or mixed including but not limited to land, mineral, or other leases.
- k. To acquire and to hold real and personal property of every class and description, including the repair, renovation or rehabilitation of the same. To borrow money and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds whether secured by mortgage, pledge or otherwise and generally to make or perform agreements.

- l. To develop, publish, sell, and create training programs and material in connection with such IT programs, the management of dental offices and training of individuals for any activities under this Corporation.
 - m. To hire, fire, transfer employees from office to office, or site to site, as needed to operate the corporate business.
 - n. To accept stocks and securities of other corporations, and take securities for the payment of all sums due the Corporation and to sell, assign, and release such securities within or without the State of Maryland or wherever situated.
 - o. To purchase, acquire, apply for, register, secure, hold, own, sell, or otherwise obtain and dispose of any and all copyrights, trade names and distinctive marks.
 - p. To carry on any other business which may seem to the Corporation to be calculated directly or indirectly, to effectuate the aforesaid objects, or any of them, to facilitate it in the transactions of its aforesaid businesses, or any part thereof, or in the transaction of any other business that may be calculated, directly or indirectly to so enhance the value of its property and directly or otherwise of its right; and to have and exercise all powers conferred and enjoyed by the General Laws of the State of Maryland and the Corporations and Associations Article of the Annotated Code of Maryland; now or hereafter in force; the enumeration of certain powers as herein specified, not being intended to exclude any such other powers, rights and privileges.
 - q. To have one or more offices and places of business and to carry on all or any of its operations and businesses, and without restrictions or limitations, as to amount or number, in any of the States, Districts, Territories or Colonies of the United States and in any and all foreign countries, subject to the laws of such State, District, Territory, Colony or Country.

- r. To establish any and all bank and credit accounts necessary for corporate functions and to write and sign checks, drafts, etc., on such accounts as needed.
- s. The foregoing clauses shall be construed both as objects and powers and shall be deemed to be cumulative and be deemed as restricting or limiting the other, nor shall the foregoing enumeration of specific powers be deemed in any way to limit or restrict in any manner the general powers hereinbefore enumerated or the general powers of the Corporation and the enjoyment thereof as conferred by law.

FOURTH: The Corporation shall have all powers enumerated under the Annotated Code of the State of Maryland, and in addition shall have all the necessary powers to enter into, perform and carry out contracts of any kind or to do any thing necessary to, or in connection with, or incidental to, the accomplishments of any one or more of the purpose of the Corporation as stated above.

FIFTH: The Post Office address of the principal place of the Corporation in the State of Maryland shall be 83 High Street, - Suite B, Waldorf, Maryland 20602.

SIXTH: The name and address of the Resident Agent of the Corporation in the State of Florida is Herman Salley, 11349 Laural Brook Court, River View FL 33569.

SEVENTH: This Corporation has authority to issue 2500 shares of common stock at \$1.00 par value per share.

EIGHTH: The number of directors of the Corporation shall be five (5), which number may be increased or decreased pursuant to the by-laws of the Corporation. Until this corporate charter shall become effective and the organizational meeting takes place, Robert Lane, Jr., shall act as the initial Director of the Corporation.
