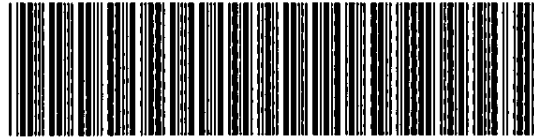


Article VII - Preemptive Rights
