ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DROPLIT INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation (defined below) hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is Droplit Inc. (the "Corporation"), with the following Florida corporation Document Number: P14000025935.
- 2 The Corporation previously amended and restated its Articles of Incorporation as of September 17, 2019 (the "Articles of Incorporation") in order to split its shares of capital stock on a 1:10,000 basis and now adopts the following Articles of Amendment to its Articles of Incorporation in order to increase its authorized shares to 11,764,713.
- 3. The text of the amendment to the Corporation's Articles of Incorporation is as follows:
 - a Article V of the Articles of Incorporation is hereby deleted in its: entirefy and replaced with the following:

"ARTICLE V

Capital Stock

- 1. Authorized Shares. The Corporation is authorized to issue one class of stock to be designated "Common Stock." The total number of shares which the Corporation is authorized to issue is Eleven Million Seven Hundred Sixty-Four Thousand Seven Hundred and Thirteen (11.764.713) shares of Common Stock (the "Common Stock"). The Common Stock shall have a par value of \$0.001 per share."
- 4. These Articles of Amendment were adopted on January 22, 2020.
- 5. These Articles of Amendment were approved and adopted by the shareholders. The number of votes cast for these Articles of Amendment were sufficient for approval. Other than as expressly set forth above, the Articles of Incorporation of the Corporation shall continue unmodified and remain in full force and effect.

6. These Articles of Amendment shall be effective upon filing.
