AND REGISTERED AGENT**

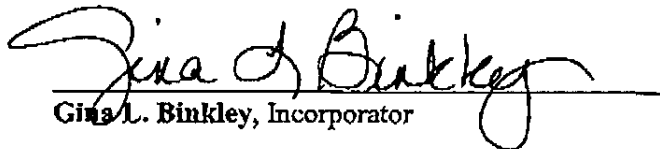

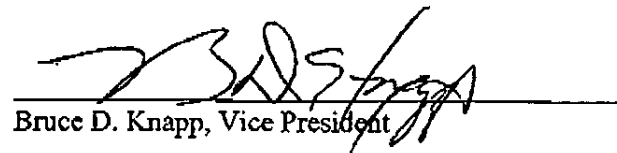
