Purpose:

The purpose of the Corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes; including but not limited to the following:

- A.) Shall acquire and accept any and all donations and investments through any means or supported currency whereby acquiring through cash, check, money order, wire transfer, foreign currency, and/or barter. These funds shall be accepted and collected as investments of capital to fund and assist various individuals, organizations, clubs, and/or causes around each community it chooses to do business for the betterment of the community and its children.
- B.) To acquire in any manner real property and to own, manage, lease, encumber, sell, convey, or otherwise dispose of said real property.
- C.) To acquire in any manner, enjoy, utilize, hold, sell, assign, lease or dispose of, letters patent of the United States or any Foreign Country, patents, patents rights, licenses and privileges, inventions, improvements and processes, copyrights, trademarks, and trade names of pending applications therefore, relating to or useful in connection with any business of the Corporation or any other business association in which the Corporation may have an interest as stockholder or otherwise.
- D.) To manufacture, purchase, or otherwise acquire, and to sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise, all article(s) of clothing, and other personal property, of every class and description whatsoever.
- E.) To act as financial, business or purchasing agent for domestic and foreign corporations, individuals, partnerships, associations, or government units.
- F.) To have one or more offices, conduct its business and promote its objects within and without the State of Florida, in other states, the District of Columbia, the territories, possessions and dependencies of the United States and in foreign countries without the restrictions as to place or amount.
- G.) To borrow money, establish credit, and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges and franchises, or for any other lawful purpose of its incorporation: to issue Bonds, Promissory Notes, Bills of Exchange, Debentures, and other obligations and evidences of indebtedness payable at a specified time or payable upon the happening of a specified event, whether secured by mortgage or unsecured, for money borrowed or in payment for property purchased or acquired, or any other lawful objects.
- H.) To purchase, hold, sell, and transfer shares of its own Capital stock, provided that it shall purchase its own shares of Capital stock only from the surplus of its assets over its liabilities, including Capital stock; and provided further that shares of its own Capital stock so purchased and owned by it shall not be voted upon directly or indirectly, nor counted as outstanding for the purpose of any stockholders quorum or vote.
