**ARTICLES OF INCORPORATION
OF**

TREEVITA BATTERSEA INC.

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

The undersigned incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is TREEVITA BATTERSEA INC. (hereinafter called "Corporation").

ARTICLE II

The principal place of business and mailing address of the Corporation is c/o 1001 Brickell Bay Drive, Suite 3112, Miami, FL 33131.

ARTICLE III

The purpose for which the Corporation is formed is to engage in any and all lawful acts or activities for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

The Corporation is authorized to issue One Hundred Thousand (100,000) shares of common stock, One Cent (\$0.01) par value per share, consisting of One Thousand (1,000) shares of Series A common stock and Ninety-Nine Thousand (99,000) shares of Series B common stock. The Series A common stock shall be voting stock, and holders of the Series A common stock shall have one vote per share in all matters subject to shareholder vote. The Series B common stock shall be nonvoting stock, and the holders of the Series B common stock shall not be entitled to vote on any matter subject to shareholder vote. The Series A common stock and the Series B common stock shall be identical in all other respects.
