**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of 101 WYNWOOD ART, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is 101 WYNWOOD ART, INC. (the "Corporation").

ARTICLE II. ADDRESS
