The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

SIXTH: The purpose of the Corporation is to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act.


SEVENTH: The duration of the corporation shall be perpetual.
