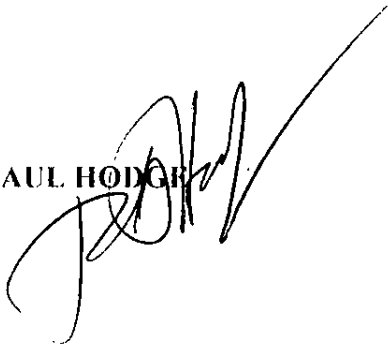

The undersigned hereby forms a corporation under the Florida Business Corporation Act, in compliance with Chapter 607, and hereby adopts the following:

**Article 1
Name**

The name of the corporation (the "Corporation") shall be:

C.B. CAMPBELL & COMPANY, INC.

**Article 2
Principal Place of Business and Mailing Address**

The principal street address and mailing address of the Corporation is 1686 Buttonbush Circle NW, Palm City, Florida 34990.

**Article 3
Purpose**

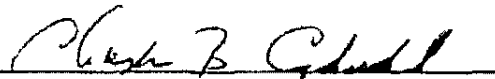
Article 8

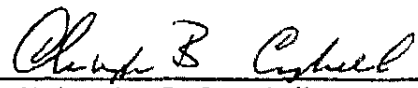
Article 9
