**ARTICLES OF INCORPORATION
FOR
HECHT CUSTOM RENOVATIONS, INC.**

The undersigned, a natural person, does hereby form a corporation under the Florida General Corporation Act, and other laws of the State of Florida.

ARTICLE ONE

The name of the Corporation is HECHT CUSTOM RENOVATIONS, INC.

ARTICLE TWO

Subject to the laws of the State of Florida regarding Corporations, the Corporation may engage in any and all activities and business permitted under the laws of the United States and of the State of Florida. 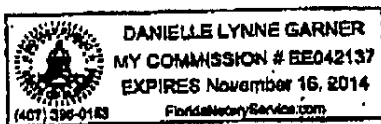
