# ARTICLES OF INCORPORATION OF NANNY HOMES, INC.

### Article I - Name

The name of this corporation is NANNY HOMES, INC. The mailing address print office of the corporation is 36 Bolling Lane, Palm Coast, FL 32137.

### Article II - Duration

This corporation shall have perpetual existence.

### Article III - Purposes

The general purposes for which this corporation is initially organized are as follows: the purchase, ownership, management, rental and sale of real properties; to own personal property; to own, hold, lease, improve and develop real estate; engage in any type of lawful business; lend or borrow money, and to draw, make, accept, discount and issue promissory notes, bills of exchange and other negotiable instruments, and to secure the same by mortgage or otherwise; to have offices and officers, agents and agencies in the State of Florida or in any other of the states of the United States, or any dependencies of the United States, or in foreign countries; and to exercise generally such powers as may be incident to or convenient for the purposes and businesses of the corporation and to engage in any activity or business permitted under the laws of the United States and the State of Florida, it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict the general powers of the corporation.

### Article IV - Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be one hundred thousand (100,000) shares of common voting stock with a par value of ten cents (\$.10) per share. All stock issue shall be fully paid.

### Article V - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

### Article VI - Initial Registered Office and Agent

### Article VII - Initial Board of Directors
