We, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, and under the statute of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of incorporating for profit, it is :

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE :

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States America.

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 2,000 shares of common stock, and ~~which common stock shall have no par value~~ (shall have a par value of \$ 1.00 per share).

All stock is to be issued as fully paid and exempt from assessment.


