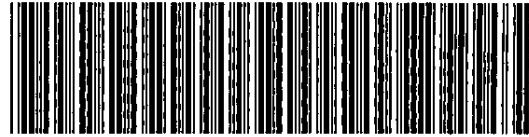



The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

**ARTICLE I**

**Corporate Name and Address**

The name of the Corporation is Youngblood Sanitation, Inc. The principal office address of the Corporation is 3010 South Street, Fort Myers, Florida 33916, and the mailing address of the Corporation is Post Office Box 4091, N. Fort Myers, Florida 33918.



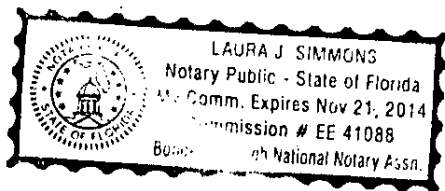


