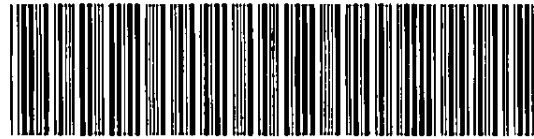


Mr. Rodriguez:


