**ARTICLES OF INCORPORATION  
OF  
EUTELSAT LATAM CORP.**

The undersigned, acting as incorporator of EUTELSAT LATAM CORP. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is EUTELSAT LATAM CORP. (the "Corporation").

**ARTICLE II. ADDRESS**

The principal and mailing address of the Corporation is 2020 Ponce de Leon Boulevard, Suite #1107, Coral Gables, Florida 33134.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.


ARTICLE IX. BYLAWS


