ARTICLES OF INCORPORATION
OF

ARTICLE I

Name. The name of the Corporation is "THE PACHENGA GROUP, INC." (the "Corporation").

ARTICLE II

Nothing in this Article shall be construed to preclude a director from serving the Corporation in any other capacity and receiving compensation therefor.

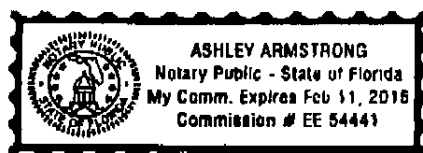
