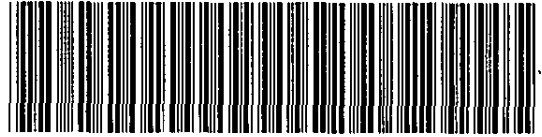

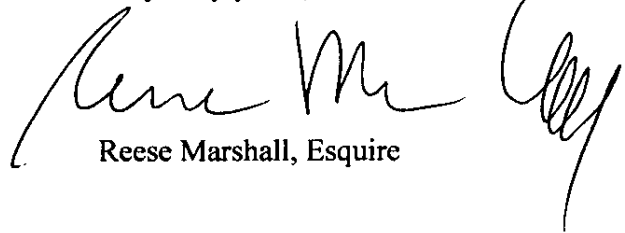

NAME

The name of the Corporation is FRED VANCE INVESTMENTS VCI, INC.

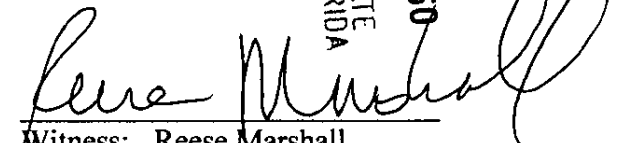
