

ARTICLES OF INCORPORATION

OF

FERLU COMMERCIAL CORP.

The undersigned acting as subscriber(s) of a corporation under the Florida Corporation of Law, adopt the following Articles of Incorporation for such Corporation.

Article I

The name of the Corporation is: FERLU COMMERCIAL CORP.

Article II
