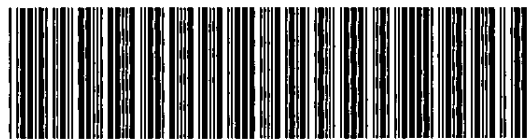

The name of this corporation is SUNGOLD JEWELRY OF BREVARD, INC.
