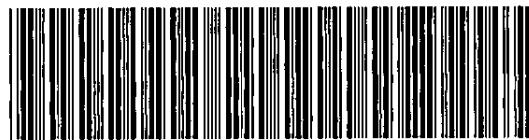

ARTICLES OF INCORPORATION
OF

Article 1. Name

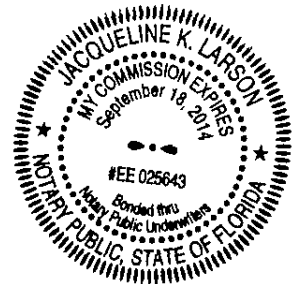
