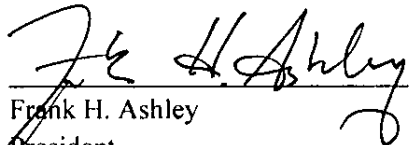
## ARTICLE X AMENDMENTS

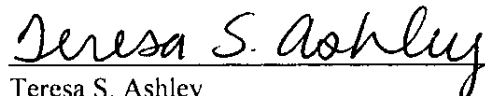
## ARTICLE XI

The shareholders of the common stock of this corporation shall have prescriptive rights to the shares of common stock or any other type of stock of this corporation hereafter issued.

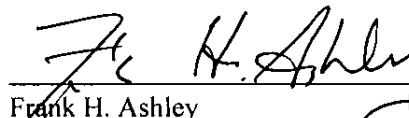
