*Pursuant to the provisions of section 607.1006, Florida Statutes, Turbine Export, Inc., a Florida corporation, adopts the following First Amendment to its Articles of Incorporation:*

**FIRST:** The name of the corporation is Turbine Export, Inc. (the "Corporation").

**SECOND:** Article 5 of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

**"ARTICLE 5  
CAPITAL STOCK**

The maximum number of shares of stock which the Corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of capital stock, par value one dollar (\$1.00) per share."

**THIRD:** The amendment set forth in paragraph SECOND of this First Amendment to the Articles of Incorporation of the Corporation was approved by the Corporation's Sole Director on July 29, 2014, and approved and properly adopted by the Corporation's sole Shareholder on July 29, 2014.
