ARTICLE I. NAME

The name of this Corporation shall be YOUR CHILD PEDIATRICS, P.A.

ARTICLE II. MAILING ADDRESS & PRINCIPAL OFFICE

ARTICLE III. COMMENCEMENT & DURATION

This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.

ARTICLE X. AMENDMENT OF ARTICLES

The power to adopt, alter, amend, or repeal the Articles Of Incorporation of this Corporation shall be vested in the shareholders by a majority vote of such shareholders.

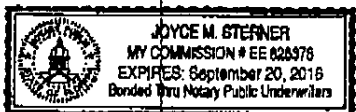



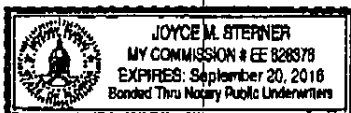
