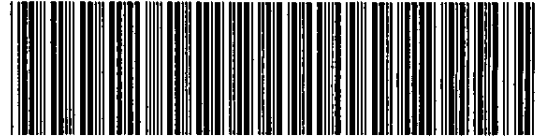



ARTICLE VII


The total number of shares which the corporation shall have authority to issue is 1 000 shares of no par value stock.
