the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable.

ARTICLE 4

Registered Office and Registered Agent

The initial registered office of this corporation shall be located at 123 W. Bloomingdale Ave., St. 245, Brandon, FL 33511, and the initial registered agent of this corporation at such office shall be Michael K. Johnson. This corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.
