CORPORATE EXISTENCE**

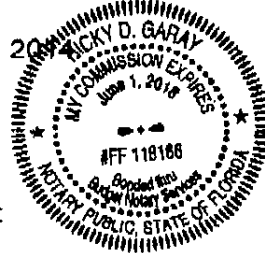
