The undersigned Corporation, in accordance with the Florida Business Corporation Act and its Bylaws, hereby adopts the following Articles of Amendment:

ARTICLE I: NAME

The name of the Corporation is "CX Insurance Services, Inc."

ARTICLE II: AMENDMENT

Article IV of this Corporation's Articles of Incorporation is hereby amended (the "Amendment") in its entirety by deleting the existing provisions of Article IV and substituting in its place and stead the following as new Article IV:

"ARTICLE IV
CAPITAL STOCK

The authorized capital stock of the Corporation shall be FIVE THOUSAND (5,000) shares of common stock having no par value, Two Thousand Five Hundred (2,500) of which shall be shares of voting common stock (the "Voting Common Stock") and Two Thousand Five Hundred (2,500) of which shall be shares of non-voting common stock (the "Non-Voting Common Stock").

Except as otherwise provided by law, the shares of Voting Common Stock shall have the exclusive right to vote on matters to be voted upon by the shareholders of the Corporation, with each share of Voting Common Stock being entitled to one vote upon such matters. Shares of Non-Voting Common Stock shall not be entitled to vote on any matter except as otherwise required by law. When the shares of Non-Voting Common Stock are required by law to vote on any matter, each share of Non-Voting Common Stock shall be entitled to one vote.

The only difference in the shares of Voting Common Stock and shares of Non-Voting Common Stock shall be voting rights, and all shares of common stock, both Voting Common Stock and Non-Voting Common Stock, shall be entitled to identical rights to distribution and liquidation proceeds."

ARTICLE III: ADOPTION

The Amendment was adopted and approved September 25th, 2015 by the unanimous written consent of all of the Directors and Shareholders of the Corporation, which consent is sufficient for approval. Except as hereby amended, the Articles of Incorporation of the Corporation is hereby ratified and affirmed.
