ARTICLES OF INCORPORATION

OF

APEX SPORTS FITNESS, INC.

ARTICLEI

Name. The name of the Corporation is "Apex Sports Fitness, Inc." (the "Corporation").

ARTICLE II

Principal Office and Mailing Address. The street address of the principal office and the mailing address of the Corporation is 5462 22nd Street South, Apt. #1409, St. Petersburg, Florida 33712.

ARTICLE III

<u>Business Purpose.</u> This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV.

<u>Capital Stock.</u> The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having no par value.

ARTICLE V

Term of Existence. The Corporation shall have perpetual existence.

ARTICLE VI

Nothing in this Article shall be construed to preclude a director from serving the Corporation in any other capacity and receiving compensation therefor.
