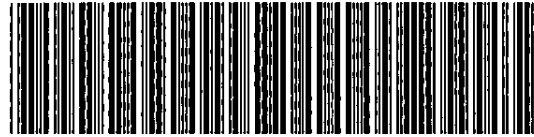

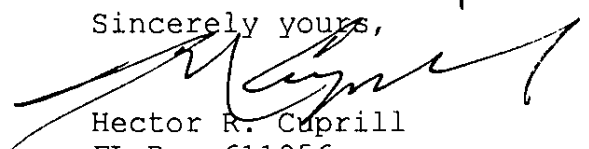

In compliance with Chapter 621, F.S. (Profit)

**ARTICLE ONE: NAME.**

The name of the corporation shall be:

**INTERNATIONAL INTERCORPORATIONS, INC.**

**ARTICLE TWO: PRINCIPAL OFFICE.**

The principal place of business of the corporation shall be located at Mainstreet Center, Suite 206, 101 N. Woodland Blvd., DeLand, Florida 32720 and the mailing address shall equally be Mainstreet Center, Suite 206, 101 N. Woodland Blvd., DeLand, Florida 32720.

**ARTICLE THREE: PURPOSE.**

A. C. In addition, the corporation shall be authorized to sell, both at the retail and/or wholesale level, any products and/or services, of any kind and nature, and likewise, to engage in any other lawful business that a corporation may duly engage in and carry out, in full accordance and compliance with the provisions of the laws, regulations and licensing requirements of the State of Florida, its cities and counties and of the laws and regulations of the United States of America.

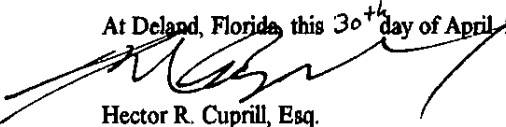
