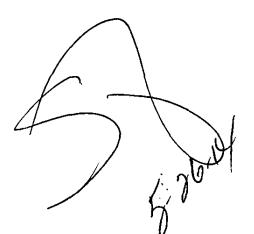

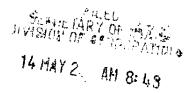

ARTICLES OF INCORPORATION OF MUIRFIELD BREEN, INC.
