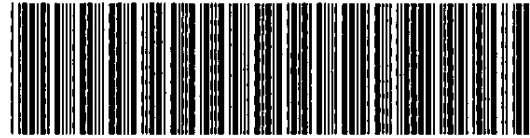

THE UNDERSIGNED, has executed the following document as
Incorporator of above named corporation, a corporation organized
pursuant to the laws of the State of Florida, and all rights, duties and
obligations of the undersigned as Incorporator, and those of the
corporation, are to be determined in accordance with the laws of the State

ARTICLE I.

This corporation shall commence existence upon the filing of these

and shall have perpetual existence.

The general nature of the business and objects and purposes

and all of the things therein mentioned, as fully and to the same extent as
natural persons might do, including but not limited to: Transacting any

manufacturing, importing and exporting clothing and accessories.

Said corporation shall further have powers:

- To sue and be sued, complain, and defend in its corporate
name in all actions or proceedings;
- To have a corporate seal, which may be altered at pleasure, and
to use the same by causing it, or a facsimile thereof, to be impressed,
affixed, or in any other manner reproduced;
- To purchase, take, receive, lease, or otherwise acquire, own,

hold, improve, use, and otherwise deal in and with real or personal property or any interest herein, wherever situated;

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

To lend money to, and use its credit to assist, its officers and employees as provided by the laws of the State of Florida.

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, limited liability companies, associations, partnerships, or individuals, or obligations of the United States or the State of Florida.

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income;
