ARTICLES OF INCORPORATION COYA, INC.

14 MAY 28 PM 12-55 SECRETARY OF STATE

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and SEE, from a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

ARTICLE I NAME

The name of the Corporation is COYA, INC.

ARTICLE II PRINCIPAL OFFICE

The principal office and mailing address of the Corporation is 4532 W. Kennedy Blvd., Suite 111, Tampa. FL. 33609.

ARTICLE III PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of Florida.

ARTICLE IV CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of \$0.01 par value common stock, which will be designated Common Stock.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

ARTICLE IX BYLAWS

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.

ARTICLE X AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.
