ARTICLES OF INCORPORATION

OF

CHOKSHI, M.D., P.A.

The undersigned incorporator, for the purpose of farming a corporation in the state of Plorida hereby adopts the following Articles of Incorporation.

Article I Name, Duration and Purpose

The name of this corporation is Chokshi, M.D., P.A. The duration of the corporation is perpetual. The general purpose for which this professional association is organized shall be (i) to render healthcare services to the general public, and to do all things in connection therewith that are customarily done by medical doctors under the laws of the State of Florida and (ii) in furtherance of its curporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation Act.

Article II Effective Date

The effective date upon which this corporation shall come into existence shall be May 29.

Article III <u>Principal Office</u>

The address of the principal office and mailing address of the corporation in the State of Florida is 1325 San Marco Boulevand, Suite 900, Jacksonville, Florida 32207.

Article IV Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.

Article VI <u>Directors</u>

- 1. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.

Article IX Amendment

This corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute, and any right conferred upon the shareholders is subject to this reservation.
