ARTICLES OF INCORPORATION

OF

DAVID A. KOSTICK, M.D., P.A.

The undersigned incorporator, for the purpose of forming a corporation in the state of Florida hereby adopts the following Articles of Incorporation.

Article I Name, Duration and Purpose

The name of this corporation is David A. Kostick, M.D., P.A. The duration of the corporation is perpetual. The general purpose for which this professional association is organized shall be (i) to render healthcare services to the general public, and to do all things in connection therewith that are customarily done by medical doctors under the laws of the State of Florida and (ii) in furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation Act.

Article II Effective Date

The effective date upon which this corporation shall come into existence shall be May 29, 2014.

Article III Principal Office

The address of the principal office and mailing address of the corporation in the State of Florida is 11512 Lake Mead Avenue, Suite 534, Jacksonville, Florida 32256.

Article IV Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.

Article V Registered Office and Agent

The street address of the registered office of this corporation is 11512 Lake Mead Avenue, Suite 534, Jacksonville, Florida 32256 and the name of the registered agent of this corporation at that address is David A. Kostick, M.D.

Article VI Directors

- 1. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.

3. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.

Article VII Bylaws

The power to adopt, amend or repeal bylaws for the management of this corporation shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the Board of Directors.

Article VIII Incorporator

The name and street address of the incorporator of this corporation is David A. Kostick, M.D.

Article IX Amendment

This corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute, and any right conferred upon the shareholders is subject to this reservation.
