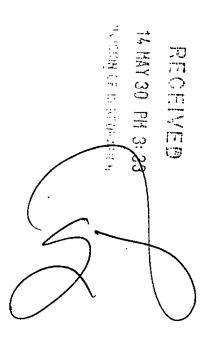

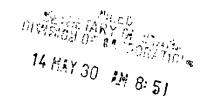

### ARTICLES OF INCORPORATION

# <u>ARTICLE I</u>

The name of this corporation is 3101 REALTY CORP. (the "Corporation").
