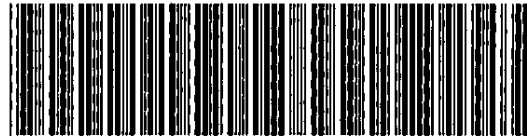

OF

ARTICLE I - NAME

The name of this Corporation is **ALL AROUND LAND, INC.** and the principal business address of the Corporation is **ALL AROUND LAND, INC.**, 1794 B South Ocean Drive, Jacksonville Beach, Florida 32250.

ARTICLE II - COMMENCEMENT AND DURATION

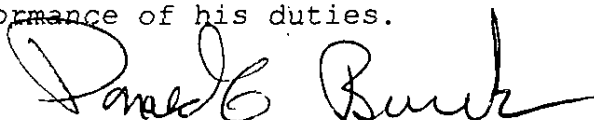
