

To Whom It May Concern:


Please find enclosed a corrected application for CSS Hinkle Enterprises, Inc., a Georgia corporation known as Pollock P.C. applying for domestication in the state of Florida. The original filing was made by Clint Hinkle (formerly, Clint Pollock), a client of ABA, in early May. The original filing contained two mistakes, both of which are listed below and have been corrected:

- 1) The original filing did not check the name availability of Hinkle Enterprises, Inc. which is currently being used in the state of Florida. Therefore, the updated application has changed the name to *CSS Hinkle Enterprises, Inc.* to avoid any conflicts.
- 2) Due to a misunderstanding by the client when filling out the original filing, the corporation name was listed as Hinkle Enterprises, LLC instead of "Inc." This was a mistake that does not indicate the preference of the entity – the desire of the client is still to function as a profit corporation in Florida. The end result should still be CSS Hinkle Enterprises, Inc.

The state of Florida has already received and processed the associated filing fee of \$128.75 (May 7, 2014). This included a certified copy of the approved application in addition to the Certificate of Domestication. On behalf of our client, I respectfully request that the state of Florida process this filing using the previous filing fee and without any further charge.




