**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of 3501 WYNWOOD ART, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME


ARTICLE IX. BYLAWS
