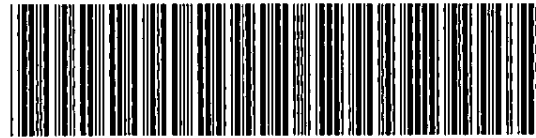

ARTICLE I: NAME

NAME The name of the corporation is **BAL-CONSULTING MANAGEMENT INC.**

ARTICLE II: PURPOSE


