The Corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

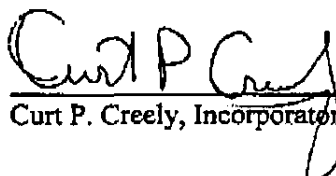

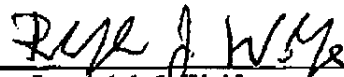
