Article IV is hereby amended as follows:

The number of shares the corporation is authorized to issue is increased from ten thousand (10,000) to fifty million fifty thousand (50,050,000). The authorized shares shall be divided into two classes: the first class, common shares , shall contain fifty million (50,000,000) shares; the second class, Series A Convertible Preferred Shares, shall contain fifty thousand (50,000). Common shares shall have unlimited voting rights and are together entitled to receive the net assets of the corporation upon dissolution. Series A Convertible Preferred Shares shall be convertible at a rate to be determined by the Board of Directors and shall have no voting rights.
